HOUSING PRESERVATION - HOUSING PRESERVATION COMBINES BOTH THE WEATHERIZATION PROGRAM AND HOUSING REHABILITATION LOAN PROGRAM. SINCE 1988, THE WEATHERIZATION PROGRAM HAS PROVIDED COST-EFFECTIVE, ENERGY-EFFICIENT HOME IMPROVEMENTS TO HOMEOWNERS AND RENTERS. WEATHERIZATION SERVICES ARE FREE TO INCOME QUALIFIED RESIDENTS IN 12 WESTERN COLORADO COUNTIES. SINCE 1991, THE HOUSING REHABILITATION LOAN PROGRAM HAS PROVIDED INCOME QUALIFYING HOMEOWNERS IN MESA, GARFIELD, AND RIO BLANCO COUNTIES ACCESS TO LOW INTEREST-RATE LOANS TO REPAIR AND MAINTAIN THEIR HOMES. STARTED IN 1997, THE SELF-HELP HOUSING PROGRAM IS A HOMEOWNERSHIP SWEAT EQUITY PROGRAM THAT GIVES INCOME QUALIFIED FAMILIES THE MEANS TO CONSTRUCT THEIR OWN HOMES. THE USDA RURAL DEVELOPMENT PROVIDES A SUBSIDIZED INTEREST RATE ON THE PARTICIPANTS' CONSTRUCTION FINANCING AND THEIR PERMANENT FINANCING. THE COMBINATION OF THE SUBSIDIZED INTEREST RATE AND THE CONTRIBUTION OF LABOR SUBSTANTIALLY REDUCES THE COST OF EACH HOME AND PROVIDES THE
